Both Fallen and Marilyn were welcomed to the committee as this was their first meeting.

- 1. Declaration of conflict of interest No conflicts present
- 2. Approval of mintues from previous meeting on 24 November 2021 circulated and approved.
- 3. Actions arising from previous meeitng.
 - 3.1. RHW consumer partnership framework

The framework is still in draft and will be circulated to the committee for comment. The reason for requiring a framework and how consumers are not only required on this committee but others too, and additionally at times on special projects was explained. Added to the framework will a business rule re factsheet development process to guide clincians.

3.2. Recruitment of consumers

Recruitment flyer is still being finalised and then we will be able to send this to our networks and to community groups. It was discussed that we require a diversity amongst our consumers too. All consumers will need to complete documents as all will be employed as contingent workers and will get stafflink numbers.

3.3. Training

The HETI consumer training modules will be accessible once consumers have stafflink numebrs and there are 4 modules to do. There is also a 3 hour workshop to be facilitated by Corallie West on 10 February 2022.

4. New business

4.1. RHW quality boards

The Local Health District are curently wanting to know what consumers would like on each of our websites. POW have infographic which was tabled. At RHW we recommend and agreed that an infographic is a good way to present the data but we at RHW need to develop our own list to be on our boards.

Firstly we recommended hand hygiene, number of births per annum, vaginal birth rate, c/section rate, breastfeeding rate could be displayed and that we could have a general collection for use on the RHW foyer quality board with each division to have on their own boards more sepctifc to that area. For example pressure injuries would be relevant to gynaecology but not other divisions. Waiting times for clinic appointments and surgery in gyneacology and even Physio would be relevant for those areas. Finally we suggested there is a need to look at the National Standards as they can guide choice as well.

4.2. National standards

Accreditation will be in May and the process of the survey discussed.

Feedback mechanisms were then discussed and what currently is available. It was agreed that the draft sheet tabled required edits and these will be sent on to Victoria in CPIU.

RHW website is being redesigned as curently is very maternity focussed. We want a one-stop shop easily accessible to consumers /patients with factsheeets on it. Discharge advice to be online too as patients can be aware of how they may be post discharge and they could be informed of this even before they are admitted.
