Dear Colleagues

I am writing to remind all staff of the requirements under the <u>Public Health (COVID-19 Vaccination of Health Care Workers) Order 2021</u> (PH Order). We want all our staff to be able to continue to work and recognise and appreciate the extremely important role every one of you plays in keeping our patients and communities safe. I thank you for your support in our response to the COVID-19 pandemic.

However, to continue to work on or after 30 September 2021, you must have had at least one dose of a COVID-19 vaccine.

To ensure South Eastern Sydney Local Health District (SESLHD) is compliant with the PH Order, we have undertaken a review of our vaccination records. If our records show that you are not vaccinated **you will receive a letter today**. If you receive a letter it means that we have no evidence that you comply with the requirements of the PH Order.

If you have received at least one dose of a COVID-19 vaccine please advise us by e-mailing your evidence to the e-mail address below before 29 September 2021:

Medical Exemption

The PH Order contains an exemption which applies only if you have a medical contraindication to the COVID-19 vaccines currently approved by the Therapeutic Goods Administration. If you have a medical contraindication, your medical practitioner will need to complete the medical contraindication form. You will then need to submit it to your manager.
