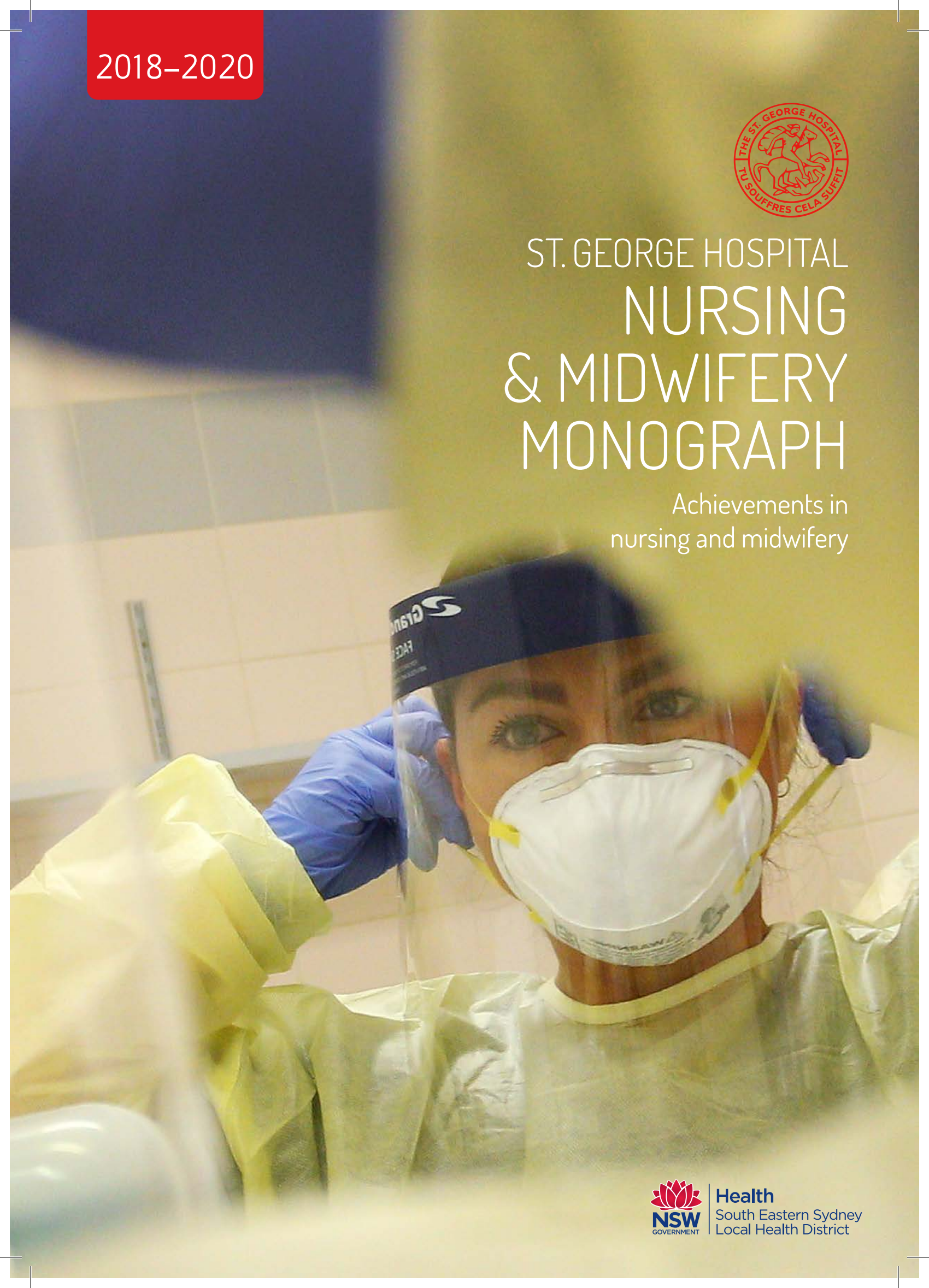

NURSING NOW

Nursing Now is a three year (2018–2020) global campaign, in collaboration with the World Health Organization and International Council of Nurses, aimed at improving health globally by raising the profile and status of nursing. Nurses and midwives are central to achieving universal health coverage, especially in the 21st Century, with the rising burden of chronic diseases, ageing populations and the impact of climate change. Nurses and midwives are crucial to health promotion, disease prevention and treatment. Therefore by encouraging health leaders to invest in nurses and midwives to maximise their contributions will ensure access to quality health services. The official Nursing Now Australian campaign launch was on 9 April 2019.

The Nursing Now campaign focuses on five core areas:

1. Ensuring that nurses and midwives have a more prominent voice in health policy-making;
2. Encouraging greater investment in the nursing workforce;
3. Advocating for more nurses in leadership positions;
4. Encouraging research that helps determine where nurses can have the greatest impact; and
5. Sharing examples best nursing practice.

Coinciding with the 200th birthday of Florence Nightingale, the World Health Organization has declared 2020 as the year of the Nurse and Midwife. To celebrate this, Nursing Now launched The Nightingale Challenge aimed at developing the next generation of nursing and midwifery leaders and advocates for health. South Eastern Sydney Local Health District (SESLHD) has accepted this challenge offering a range of leadership programs for nurses and midwives throughout the organisation. SESLHD has also been participating in the Nursing Now Australia Challenge Calendar which is a monthly challenge aimed at supporting the objectives of the Nursing Now campaign that commenced in May 2019 and concluded on the 200th anniversary of the birth of Florence Nightingale on 12 May 2020.

CENTRE FOR EVIDENCE-BASED INITIATIVES IN HEALTH CARE: A JOANNA BRIGGS INSTITUTE CENTRE OF EXCELLENCE

The Joanna Briggs Institute is an independent, international, not-for-profit research and development organisation based in the Faculty of Health and Medical Sciences at the University of Adelaide, South Australia. JBI is concerned with improving health outcomes in communities globally by promoting and supporting the use of the best available evidence to inform decisions made at the point of care. A range of evidence-based practice tools and resources such as systematic review and clinical audit tools, evidence-based point of care resources; offering educational programs to further support those who seek to access, appraise or use research evidence are available.

Supported through the provision of clinical resources by the St. George Hospital and University of Wollongong, the Centre for Evidence Based Initiatives in Health Care was established in 2014. The centre creates opportunities for clinicians, academics and other key stakeholders to make a significant impact on the delivery of high quality clinical care, education and leadership through evidence generation, synthesis, transfer, and utilisation.

PRIORITIES & PROGRAMS

COVID-19 Pandemic Research

The COVID-19 pandemic has caused high levels of disruption and uncertainty for people globally. COVID-19 has brought challenges for us all, with frontline workers facing unprecedented pressure. A series of research projects led by Professor Ritin Fernandez aims to explore the effects of COVID-19 on the psychological health and wellbeing of SESLHD Nursing and Midwifery staff, university students and the general population.

COVID-19 pandemic: Assessing the wellbeing of SESLHD Nursing and Midwifery staff

This project is a collaborative effort between staff at St George and Sutherland Hospitals and the University of Wollongong. A survey was sent to all Nursing and Midwifery staff within SESLHD in May 2020 to assess the health and wellbeing of staff during the COVID-19 pandemic, including the impact on their work, social and family life. This study will help identify the staff most at risk so that support can be targeted where it is most needed during this difficult time.

COVID-19 pandemic R U OK: Assessing the wellbeing of pre-registration nursing students

To assist in identifying how the COVID-19 pandemic impacted pre-registration nursing students study, clinical placements, wellbeing and their use of coping strategies, a survey was conducted between April – June 2020. The study was conducted across two Australian universities and one international university.

The COVID-19 pandemic in Australia: wellbeing and social determinants of health

The social and economic consequences of the pandemic are expected to affect all population groups; however, they are expected to impact those from a lower socio-economic areas and vulnerable population groups substantially. This PhD mixed methods research undertaken by Heidi Lord under the supervision of Professor Ritin Fernandez seeks to explore the relationship between the social determinants of health and the wellbeing of adult Australians during the COVID-19 pandemic.

Working to achieve the UN Sustainable Development Goals in Cameroon, Africa

The nurse researchers at the Centre for Research in Nursing and Health at St George Hospital have been collaborating with nursing researchers in Cameroon, Africa working to achieve the UN Sustainable Development Goals. This collaboration through research is aimed at providing best evidence based practice to combat neglected tropical diseases such as trachoma and to address the issues related to infertility and blood donation.

The trachoma research aims to develop an understanding community knowledge, perceptions and practices in relation to intervention programs. The research seeks to address, using best available evidence, potential barriers that hinder successful implementation of global intervention programs for trachoma such as the SAFE (Surgery, Antibiotics, Facial Cleanliness and Environmental Improvements) strategy.

Our research relating to infertility will highlight both the clinical and socio-cultural consequences of infertility in women living in Africa. In particular, we intend on conducting research to bring awareness to and a broader understanding of the personal experiences of women living in Africa who are infertile in order to inform better treatment strategies and to reduce the burden.

The healthcare systems across Africa are experiencing inadequate and unsafe blood donations due to the reluctance of potential donors. Our research aims to better understand the thoughts, beliefs and knowledge of people within African communities relating to blood donation in order to inform evidence based policy changes and the development of health promotion programs to promote blood donation.

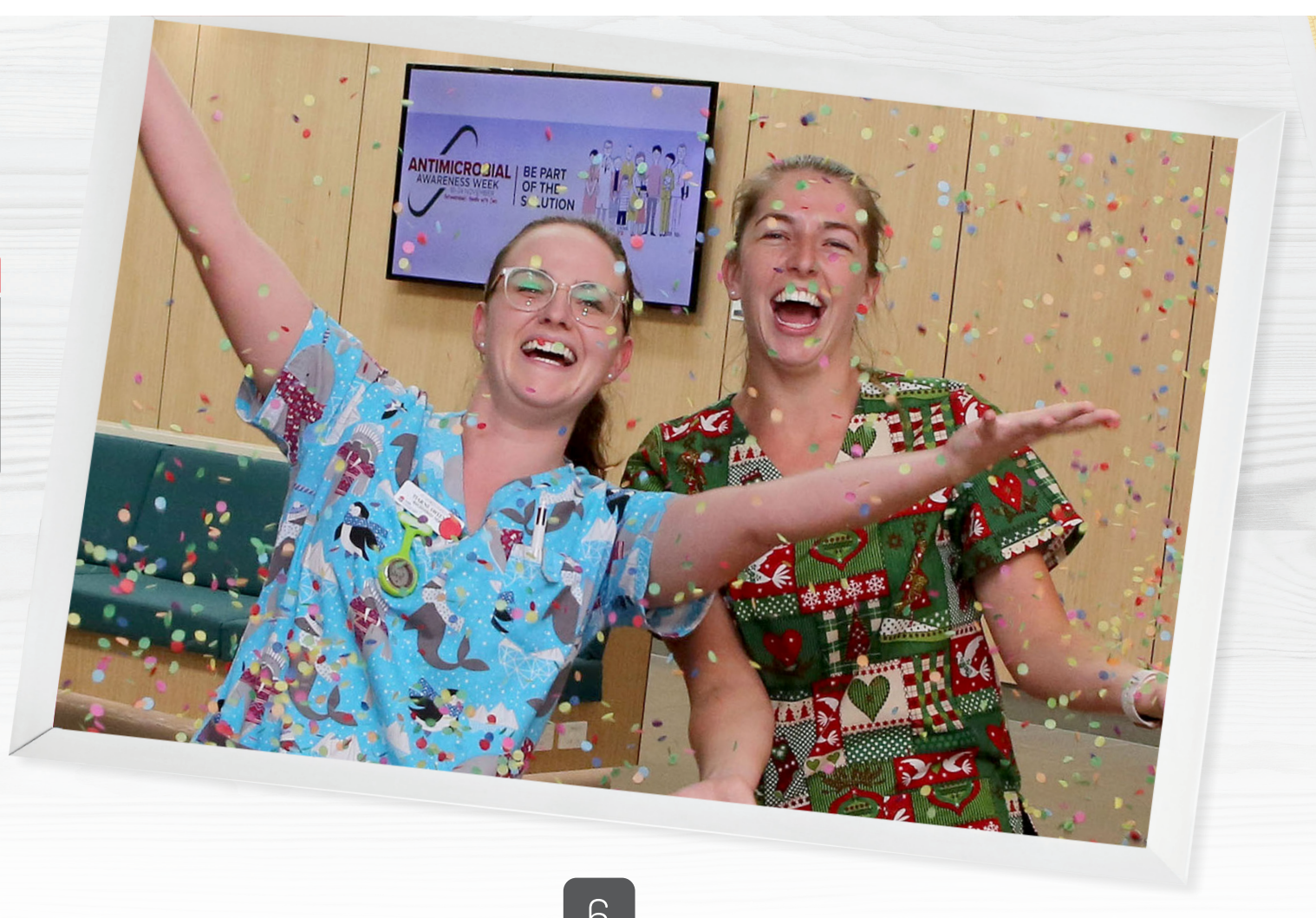

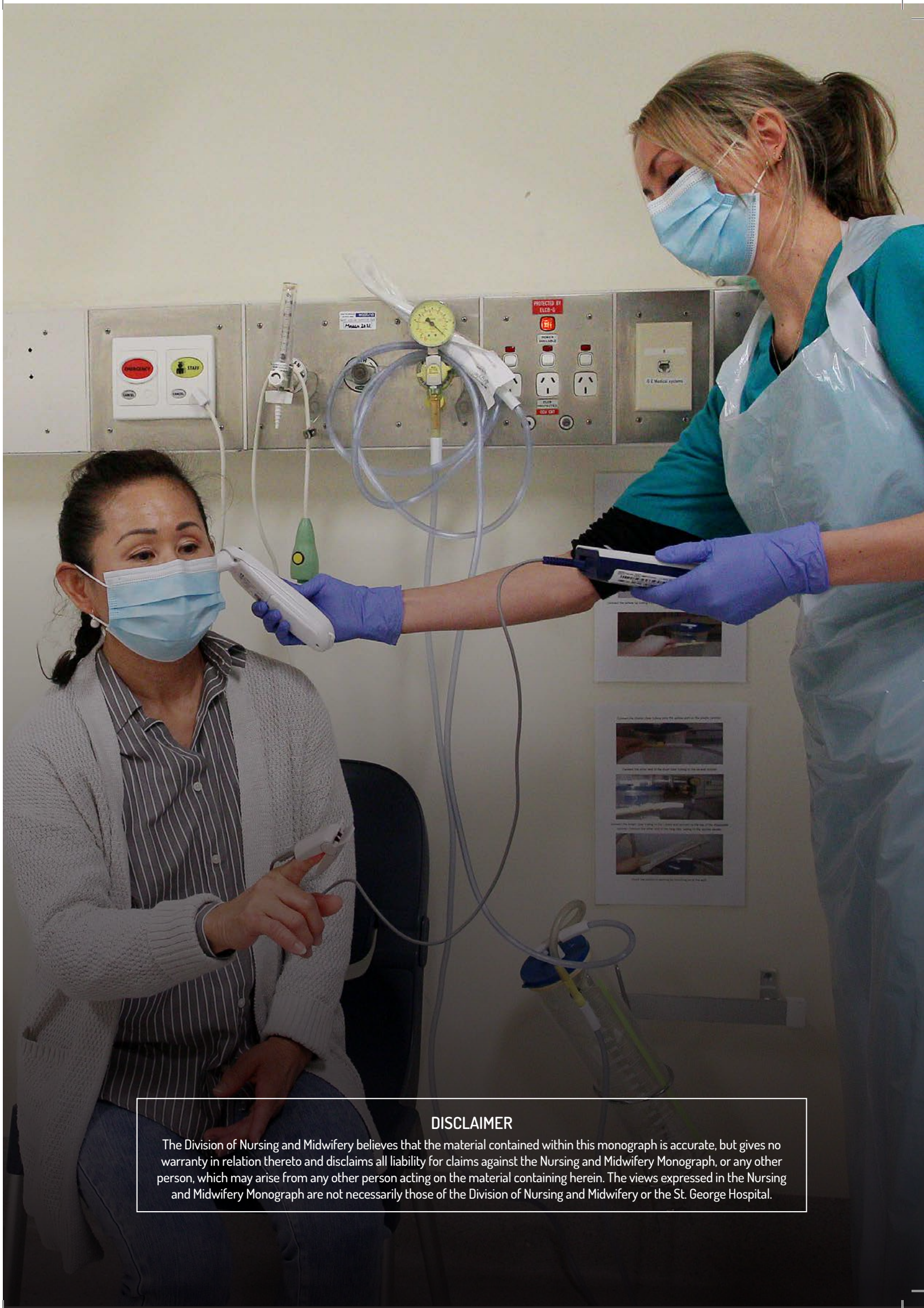
