MRI Project

This year the Minister for Health & Medical Research, The Hon. Brad Hazzard MP announced \$7 million in funding for an MRI for The Sutherland Hospital. This investment is in addition to the \$81.5m for The Sutherland Hospital Operating Theatre Upgrade Project. It is a fantastic outcome for the hospital and residents of The Sutherland Shire community.

Marilyn Urch and Sandra Hudson, community campaigners for the MRI at the Sutherland Hospital, have been recognised by NSW Attorney General, the Hon. Mark Speakman MP, during a speech in Parliament house regarding their hard work petitioning for the new MRI.


Design milestone for our upgrade project

As we draw a close to 2020, the Sutherland Hospital Operating Theatre Upgrade Project is close to signingoff on major design milestones. Project User Groups have been meeting to review plans for each area as part of Schematic and Detailed Design.

This work, undertaken with the architects, started with Schematic Design to map out the adjacencies of services. The location of operating theatres, patient bays, outdoor spaces, work spaces, and much more has been discussed as part of the process.

More recently the teams have worked through Detailed Design, where the Project User Groups have focused on room lay-outs, including furniture, fixtures and equipment, down to the level of detail for each power point.

With over 20 Project User Groups, staff input and expertise has been critical to getting to sign-off point.

Change management: What to expect

As well as improving the environment in which care is provided and staff are working, the project will represent a transformational change to health care delivery at Sutherland Hospital. It will impact directly on:

- PEOPLE patients, carers, community members and our staff
- **PROCESSES** service models and models of care, new ways of working, our policies, procedures and workflows
- TECHNOLOGY mobile devices, communication and new medical equipment
- **CULTURE** the formation of new teams working within new environments, and strengthened relationships between services.

After a year of design and planning, construction will commence next year. To fully realise the opportunities for change, significant organisation, planning and preparation will be required over the next three years to ensure that we are prepared for "go live."



Sutherland Hospital Operating Theatre Upgrade Project Aboriginal Liaison Committee and will reflect the rich local culture recognising Aboriginal history.


In preparing and delivering the Arts and Culture Strategy, our approach will include:

- Development of a diverse range of contemporary art experiences, applied in strategic locations, designed to soothe, relax and delight
- Development of projects of an international standard for art and design in a hospital setting.

Community Update

In October, the Project team, hosted a virtual Community Information session to provide a planning update to consumers, residence and the local community. The forums reviled the artist's impressions of the architectural designs, a planning update and information about the recently announced MRI project.

The team responded to a variety of questions across topics including planning of services, details about the MRI project and commencement of construction. The Sutherland Hospital Operating Theatre Upgrade Project will continue to share regular updates via the website and hold virtual information sessions at key milestones of the project to keep you up-to-date, answer your questions and receive feedback about the redevelopment.
