Project Top 5 – Carers program – Inpatients Project

This project is a way of engaging with carers of patients with memory loss to develop strategies to improve the outcomes for these patients during their hospital stay.

Strategies that families might use eg handling aggitation – look at how to deal with it – notes go with patients.

Posters showing the Top 5 steps are on wards (Elizabeth will provide to members).
