Confirmation of previous Minutes – Peter Lewis

Guest Speaker: Mr Adam Muggleton from Billard Leece, architectural consultants

Mr Muggleton gave an overview of the extension plans for The Sutherland Hospital over the next 50 years and more comprehensive plans for the next 10-15 years with plans for new buildings and car parks

Stage 1 will involve the building of a new Emergency Department area expanding to the western side of the site

Stage 2 will involve the construction of a car park south of the Kingsway and a new entrance from the Kingsway with traffic lights enabling drivers to turn right into the site and a community centre to be constructed on the corner of the site. Buildings will be built up as opposed to spreading over the site.

Stage 3 – Mental Health facilities on North-east side of site - Major security link from back car park to main part of hospital

Stage 4 - demolish loading dock - expand clinical services area

Stage 5 – more expansive work south area and development of small under croft parking
